OTHER DUES AND FEES

- **Building Fund:** \$300/year for six years, beginning in the second year of membership to support operations/maintenance.
- Optional Jewish Theological Seminary dues: \$25
- Optional Mercaz dues: Single: \$36 / Family: \$54

Beginning July 1, 2023, Bar / Bat Mitzvah fees will be billed at \$1,800 over two years. Please note that all accounts must be in good standing 3 months prior to the simcha date.

Facility Rentals require a **50% deposit** within 30 days of signing the contract. The remaining 50% must be paid in full 45 days prior to the event. Payment plans are available upon request.

If you wish to join Brotherhood / Sisterhood, please pay those amounts in full, either along with your Temple payment or separately.

SPECIAL DUES INITIATIVE

Next Generation Membership: If you are 36 years of age or younger, we have not assessed you any dues, but we ask that you consider a voluntary contribution which will be reflected on your Temple statement. The NextGen membership initiative applies until the older member of your household is 37 years of age.

Optional Add-Ons for Temple Emanuel:

- Jewish Theological Seminary dues: \$25
- Mercaz dues: Single \$36 / Family \$54
- Brotherhood / Sisterhood: \$36

Due within 30 days of statement. See p. 2 for payment options.

^{**}Distance Membership: For members who live more than 100 miles away 6 months per year (not eligible for member rental rates).



QUESTIONS

What are the payment options?

We have four payment options for Membership dues, Building Fund, JTS, and Mercaz.

- 1.100% payment 30 days from date of invoice
- 2. Quarterly payments due July 31, September 15, December 15, and March 15
- 3.25% Due by July 31 and payment of full balance by December 31
- 4. Ten monthly payments beginning July 31 and ending April 15

What if I cannot afford the full amount of the dues and fees?
